Country News

Czech Republic

News from the Czech Republic

In early intervention service we keep developing interdisciplinary cooperation, especially with phoniatrists, but also with other experts, in the form of regular meetings in regions, where we travel to visit clients. As part of our consulting work with clients, we standardize information and practical demonstrations of visual communication tools that help parents adopt a new way of communicating with their children, especially in the first period after a hearing loss is detected. We are planning to participate in the EURLYAID conference, which was held two years ago in Prague and will be held in Lisbon this September.

Methodological work is also underway on quality standards and methodological guidelines for the service. We currently also have significant experience (as a part of social activation service) with a family conference in the case of three children, where approximately 6 institutions are involved. Two of our colleagues will participate in training in Peter Limbrick's TAC (The Team Around the Child) method, which is hosted in the Czech Republic.

The amount of the humanitarian benefit for persons from Ukraine granted temporary protection will be increased. In the case of children with disabilities, it will be 11,835 CZK (474 euro) from the current 5,235 CZK (209 euro). The current amount of the humanitarian benefit for disabled adults is 7,290 CZK (292 euro) and will be 11,690 CZK (468 euro).

Our full time psychologist has a full capacity of the clients. She has started the "Play Therapy Training" which is very useful for deaf children and all children who do not speak.

Our organization launched a campaign on social media on the occasion of World Hearing Day. Four persons made reels about how they are taking care of their hearing or their child's hearing.

We are also preparing a family camp and other events. In March there was a traditional reading event for children with a sleepover called Night with Andersen. The event was lead by a deaf role model and it was translated to Czech sign language. I would like to invite you all to participate in this international event in your country. Spain

FIAPAS' commitment to hearing loss detection: New CODEPEH Recommendations on Postnatal Hearing Loss Detection in Children

In line with its 2024 campaign "<u>Let Everyone Hear It</u>", the Spanish Confederation of Families of deaf people (FIAPAS), in collaboration with the Spanish Commission for the Early Detection of Hearing Loss (CODEPEH), has released a new scientific report focusing on the early detection of postnatal hearing loss in paediatric populations.

The report highlights the potential of school-based hearing screening programmes as a viable and effective approach for identifying hearing loss that develops after the newborn stage. It proposes the use of tele-audiology as an innovative solution—enhanced by artificial intelligence—to increase both the efficiency and accuracy of detection systems.

These emerging techniques bring multiple advantages:

- ✓ Greater availability,
- ✓ Simplicity of use,
- ✓ Improved precision in hearing assessments,

 \checkmark And the ability to carry out screenings remotely and independently, reducing the reliance on specialised personnel.

All findings and recommendations have been compiled into a new <u>CODEPEH Position Paper</u>, accompanied by **public information materials** (a <u>leaflet</u> and <u>flyer</u>). These resources are designed to help **health and education professionals, as well as families**, recognise **key warning signs** and understand the **importance of timely detection**, **diagnosis**, **and intervention** for postnatal hearing loss.

This initiative aligns with the 2024 FIAPAS Manifesto, which calls for:

- Improved public health strategies for hearing loss prevention and care,
- Greater support for families,
- And stronger investment in technology and early intervention.

Finland

The NGO sector has experienced quite a bit of turbulence this year. State subsidies for social and health organizations, known as STEA grants — which also serve as the main source of funding for the Finnish Association of Parents of Deaf and Hard of Hearing Children (KLVL) — were reduced at the beginning of 2025. This year, organizations received nearly €80 million less in grants than before, with the total amount decreasing from €384 million to €304 million.

Although the cuts have not yet directly affected KLVL's operations, they are set to continue next year and are then expected to impact KLVL as well. At present, organizations face uncertainty regarding the 2026 grants, which is causing concern both within the organizations and among the people they support. We have prepared carefully for this situation to ensure that support for families of deaf and hard of hearing children can be maintained as effectively and efficiently as possible.

The situation in Finland is especially concerning because the position of people in vulnerable situations in Finland has already deteriorated. The center-right government led by Petteri Orpo, which took office in June 2023, has implemented significant cuts to social security — particularly to unemployment benefits, student support, and housing allowances — further undermining the livelihood of low-income individuals.

Despite some uncertainty, KLVL's operation in 2025 has progressed with determination and a positive spirit! Our courses, camps, and events have filled up quickly, with some people even left on the waiting list. At the moment, we are preparing for our traditional Summer Days, taking place 27–29 June in Piispala, Kannonkoski. We expect around 20 families of deaf and hard of hearing children to join us there. We are also filming a new presentation video of KLVL, which we look forward to sharing with everyone!
